## **SUMMARY OF THE ACTIVITIES**

#### **ONLINE ACTIVITIES**

- Online activities will be carried out through ENTraNCE for Judges online platform (<a href="http://comsmedia.elearning-fsr.net/">http://comsmedia.elearning-fsr.net/</a>). In January 2019, each participant will receive a username and password to access the platform, as well as the instructions for using the platform.
- You will not be required to get access to the platform at specific time of the day. However, we would like to ask you to check regularly the platform for updates.
- Different kinds of activities will be carried out within the on-line platform:
  - Preliminary questionnaire: in January 2019, we will ask you to fill an online questionnaire to assess your background knowledge and professional experience in the field of competition law
  - 2) Online forum of discussion: throughout the program we will post news on recent judgements and decisions in the field of competition law. We invite you to comment online the news, and to upload relevant news from your country as well, in order to stimulate the online discussion among the participants
  - 3) <u>Suggested readings:</u> some suggested readings will be uploaded on the online platform. We encourage the participants who are less familiar with the topic to have a look at the readings.
  - 4) Individual case note: in the context of the online activities we would like to ask each participant to write a short case note (i.e. 3-5 pages), commenting one judgement from your home jurisdiction in the field of competition law. The case note should be written in English, including the summary of the judgement and brief personal comment. The case notes will be uploaded on the online platform. In addition, you will present the case note during the final workshop in Florence on 26<sup>th</sup> 28<sup>th</sup> September 2019. Finally, the case notes will be included in a collective working paper published by the RSCAS at the end of the training program.

#### RESIDENTIAL ACTIVITIES IN FLORENCE

- The residential activities in Florence will include a residential training (31<sup>st</sup> January 2<sup>nd</sup> February 2019) and a final workshop (26<sup>th</sup> 28<sup>th</sup> September 2019).
- The residential training will mainly consist of lectures and group exercises on competition law and economics. The lectures will be delivered by leading academics in the field. During the final workshop, on the other hand, you will be asked to actively participate in a round-table of discussion, by presenting the case note that you wrote in the context of the online activities.
- Coaching: participants who are facing a real competition law case may rely on a coaching service provided by Prof. Parcu and Prof. Monti in the contest of face-to-face sessions during the residential training and final workshop in Florence, as well as throughout the online activities. The coaching is optional; further information will be provided in January 2019.
