## Structure of the week of the online training

- FRIDAY BEFORE: Background and group work materials for the following week is uploaded to the e-learning platform.
- MONDAY TUESDAY: Individual learning activities.
- WEDNESDAY: The live class takes place from 13:00 to 14:30 (CEST) via Zoom. After the live class, a hands-on session from 15:00 to 16:30 is dedicated to a group work or a case study. Participants can be divided in multiple breakout rooms to work in smaller teams. The lecturer and the course coordinator enter the different breakout rooms to help the participants if needed. As an exception, the class on week 3 will take place on Tuesday 20<sup>th</sup> June (instead of Wednesday).
- **THURSDAY:** The self-evaluation assessment is made available on the platform; the forum for collective discussion is open and additional reading material is uploaded.
- FRIDAY: Individual learning activities.

#### **Virtual Classrooms**

- The live class takes place every week, from 13:00 to 14:30 CEST.
- The instructor makes a presentation (i.e., max. 75 minutes) based on a PowerPoint (recommended length: 30/45 slides), possibly allowing for 5' break in between (if it fits the structure of the lecture) and for questions and clarifications all along the lecture.
- In between the class and the group work, a break of 30' takes place.
- The 90' hands-on session puts into practice the key messages delivered during the lecture through a case study or group exercise. The idea is to provide participants with case study or group exercise instructions a couple of days before the session, pre-assign them into breakout rooms and give each group the instruction ask to put together a PowerPoint or bullet points to be presented by a designated person in each group.
- The recording of the virtual sessions will be made available on the platform as soon as possible during the week.

#### **Group exercise**

- A group exercise follows every virtual class. The group exercise lasts 90 minutes.
- Training participants are divided in small groups, via the Zoom break-out rooms.
- The group exercise could include a hypothetical case (i.e., mock case), related to the topic of the virtual class.
- Every group has 30 minutes time to read and discuss internally the mock case, followed by a general discussion.
- The instructor of the week supervises the discussion in the Zoom break-out rooms.

#### Forum of discussion

- The instructor should provide the text of a topic to be posted in the forum to start a collective discussion after the virtual class.
- During the week, participants can continue interacting with the instructor by posting follow-up questions.

## Weekly assignment

- The weekly assignment consists of a self-evaluation assessment (10 questions with 3 or 4 different options and some feedback for each answer only one option should be correct), which participants can undertake after the virtual classroom.
- Completion of the weekly assignment is necessary to receive the certificate of excellence.
- The instructor of the week provides the list of multiple-choice questions, as well as the correct answers.
