

 "If analysts and operators are to increase their ability to achieve desired policy outcomes, ... we shall have to find ways of thinking harder about the problem of 'implementation,' that is, the path between the preferred solution and actual performance of the government."

- Bespoke Postal Regulators: Unusual
  - Main example: US Postal Regulatory Commission
- Multi-Function Agencies: Scale and Scope
  - Communications (telecom/postal): Arcep, Ofcom
  - Competition, consumer, postal, telecom: ACM
  - Competition, consumer, postal, telecom, energy, transportation: CMNC
- Integration by Inter-agency Consultation

### Assignment of Roles

- Complementarities in Theory and Practice
  - Degree of internal integration?
- Integration by Agreement/Collaboration
  - Mandatory consultation: e.g., Australia
  - Common working groups
  - Role of academic hubs : Paris-Dauphine,EUI, CRRI
