

FLORENCE COMPETITION AUTUMN SCHOOL

Recent Developments in Competition Policy
23-27 October 2022



The Florence Competition Autumn School is an advanced course that immerses mid-career participants into the cutting-edge developments in competition policy in Europe, the USA and the rest of the world. It offers a full learning experience through a combination of hybrid frontal lectures, e-learning activities, real-life competition law scenarios and in person social events in Florence and its world-famous Chianti surroundings. Residential and online attendees learn under the lead of a top-notch international faculty while growing their network of competition law peers. Gathering as lecturers well-known academics, practitioners and competition agencies representatives, the School adopts an interdisciplinary training approach that crosses the fields of law, economics and policy. Early to mid-stage professionals will strengthen their intellectual and practical foundation for the application of competition law and economics in their everyday work.

The Florence Competition Autumn School will take place at Villa Schifanoia, part of the EUI campus: a beautiful 14th-century manor located in the foothills outside Florence. Due to possible travel predicaments, the Autumn school features a 'hybrid' format: participants can either opt for the 'residential' track (i.e. attending the Autumn School in person, at the EUI campus in Florence) or 'online' one (i.e. attending the Autumn School via Zoom). Both tracks provide participants with access to the live classes and e-learning materials.

The Autumn School is organised by the Florence Competition Programme (FCP) and the Florence School of Regulation, Communications and Media (FSR C&M), both based at the Robert Schuman Centre for Advanced Studies (RSCAS) of the European University Institute (EUI) in Florence (Italy). The FCP and the FSR C&M carry out analytical and empirical research on key competition law and sectoral regulation issues thereupon organising state-of-the-art residential and online executive courses for over ten years.



